Healthy Start - Healthy Start program services are support services provided to pregnant women, infants, and young children identified as at risk for poor health outcomes with goals of reducing infant mortality, decreasing low birth weight births, and improving infant/child health and well-being. During FY 16/17 a total of 6890 women and infants received Healthy Start program services. During FY 16/17 a total of 3051 pregnant women received MomCare program services. (MomCare is a component of the Healthy Start program).

4b (Code:) (Expenses \$ **633,411** including grants of \$ **63,596**) (Revenue \$ **661**)

Healthy Families - The goal of the Healthy Families program is to prevent child abuse and neglect before it ever starts through voluntary home visiting services. During FY 16/17, 150 families received Healthy Family program services.

4c (Code:) (Expenses \$ **367,270** including grants of \$ **157,903**) (Revenue \$ **25,894**)

Outreach and Family Engagement services. During FY 16/17, a total of 767 individuals received Neonatal Outreach and WIS services. During FY 16/17, a total of 566 individuals received Community Cafe services. During FY 16/17, a total of 163 individuals received Family Engagement Services. During FY 16/17, a total of 64 individuals received Intensive Case Management Services.
