During FY 15/16 a total of 7172 women and infants received Healthy Start program services. During FY 15/16 a total of 3752 pregnant women received MomCare program services. (MomCare is a component of the Healthy Start program).

Healthy Families - The goal of the Healthy Families program is to prevent child abuse and neglect before it ever starts through voluntary home visiting services. During FY 15/16, 122 families received Healthy Family program services.

4c (Code:) (Expenses \$ **331,699** including grants of \$ **126,454**) (Revenue \$ **13,842**)

Outreach and Family Engagement services. During FY 15/16, a total of 378 individuals received Neonatal Outreach and WIS services. During FY 15/16, a total of 306 individuals received Community Cafe services. During FY 15/16, a total of 109 individuals received Family Engagement Services.
